It is "Vision"'s first systematic study from the dual perspective of a Hispanist and a Hebraist. Populist nationalism fuses beliefs that citizens are being exploited by a privileged elite with claims that the national culture and interests are under threat from enemies within or without. Ideologically fluid, populist nationalists decry "out-of-touch" institutions such as political parties and the mainstream press while extolling the virtues of the "people." They claim that only populists can truly represent the nation and solve its problems, and often call for unorthodox solutions that appeal to the common people. The recent spread of populist nationalism throughout the world has triggered a growing interest in the subject, led mainly by journalists. The Brexit vote and the election of Donald Trump in the US have provoked a flurry of media coverage in Europe and the Americas, along with parliamentary debates. Some social scientists have sought to explain the resurgence of nationalism and the spread of populism in recent decades, but important questions remain and most of the scholarship has not adequately addressed the fusion of nationalism and populism. It fails to examine the combination of populism and nationalism comparatively, especially the contrast between the more progressive and leftist versions such as

those in Latin America, and the more traditional conservative varieties that are gaining strength in Germany, the United Kingdom, and the United States. This interdisciplinary collection by experts on Europe and the Americas fills this void. The volume examines various experiences with populist nationalism, and offers theoretical tools to assess its future. Some chapters are in-depth country case studies and others take a broader perspective, but all open the door for meaningful comparison. A study and edition of one of the most ignored works of early Spanish literature because of its strong sexual content, this work examines the social ideology that conditioned the reactions of people to the events it describes as well as Fernando de Rojas's masterpiece, *Celestina*. *The Presented Past* is concerned with the differences between the comparatively static, well-understood way in which the past is presented in schools, museums and at historic sites compared to the approaches currently being explored in contemporary archaeology. It challenges the all-too-frequent representation of the past as something finished, understood and objective, rather than something that is 'constructed' and therefore open to co-existing interpretations and constant re-interpretation. Central to the book is the belief that the presentation of the past in school curricula and in museum and site interpretations will benefit from a greater use of non-documentary sources derived from archaeological study and oral

histories. The book suggests that a view of the past incorporating a larger body of evidence and a wider variety of understanding will help to invigorate the way history is taught. The Presented Past will be of interest to teachers, archaeologists, cultural resource managers, in fact anyone who is concerned with how the past is presented. El període més conflictiu i dramàtic de la història espanyola del segle XX és, sens dubte, el de la Guerra Civil i el de la dictadura franquista, pel que es converteix en un dels temes més delicats a l'hora de tractar-lo en els manuals d'història. En aquest estudi s'analitza la forma en que els manuals d'història (en el franquisme, en la transició democràtica i en la més recent actualitat) han tractat i tracten el període comprès entre 1931 i 1975. La investigació analitza la forma i el grau que els programes i manuals escolars d'història d'educació secundària han contribuït a l'enfortiment de les conviccions democràtiques dels joves i a la generació d'una reconciliació viable amb el complex i dramàtic passat espanyol respecte dels seus moments més difícils i controvertits, la Guerra Civil i el període franquista. La información ofrecida por cuatro millares de casos civiles y criminales de la cantabria rural de la época muestran una sociedad rural con códigos consuetudinarios de cooperación y de violencia tan fuertes que hacen insuficiente el esquema foucaultiano para explicar esa realidad. Conflictividad y Disciplinamiento Social refieren a dos escenas complementarias, es decir, al análisis de los conflictos y a las formas de resolución de los mismos, cualquiera que fuera su fuente, naturaleza y concreción.
